

## **AEON Credit to e-Points (1 August - 8 October 2017)**

### **Campaign Terms and Conditions**

**Before using the Club Panasonic AEON Credit Campaign Promotion, hereinafter referred to as the Promotion, please spend a few minutes to read the following Terms and Conditions. By using this Promotion, we will assume that you have read these Terms and Conditions and that you have agreed to them. They are binding on CLUB Panasonic, AEON Credit Service and Promotion users.**

1. The Promotion is issued by PANASONIC MALAYSIA SDN. BHD. (26975-W), hereinafter referred to as "PANASONIC", in collaboration with AEON Credit Service (M) Berhad (412767-V), hereinafter referred to as "AEON Credit".

7. Easy Payment customers will be entitled for complimentary 2X Club Panasonic e-Points and Delay Initial Payment with the following conditions:
  - a) Approved AEON Credit Easy Payment applications only.
  - b) Minimum financing tenure 24 months.
  - c) Minimum finance amount RM 1,000.00.
  - d) Purchase of Panasonic brand products only (all products categories).
8. The minimum gross income for a qualified applicant is RM900.00.
9. All applications are also subject to stock availability at each selected location / center.
10. AEON Credit shall process the applications and the approval is subject to our AEON Credit's terms and conditions. The application will be processed within 3 working days provided that required document/information, approval process period may extend.
11. All application approvals are subject to AEON Credit's assessment guidelines and deemed final.
12. This promotion shall not clash with other Panashop or AEON Credit Easy Payment scheme promotion that runs concurrently.
13. Selected products, such as Camera, Camcorder, Fridge, Microwave Oven, Viera TV, Washing Machine, Air Purifier, and Home Entertainment Program Panasonic Products are entitled for complimentary Quadruple (4X) Club Panasonic e-Points under the Promotion's Terms and Conditions.
14. The 4X Club Panasonic e-Points benefit can only be claimed for eligible customers when the e-warranties for their related purchases have been registered by their respective Panashop dealers.

15. Club Panasonic e-Points can be used to redeem Panasonic e-Voucher at Panasonic Online Store.
16. Normal Calculations for Club Panasonic e-Points:  
RM1 finance amount = 1 Club Panasonic e-Point.  
E-Voucher value entitlement: RM1 = 100 E-Point.
17. Calculation for 2X e-Points for any Panasonic Products under the Promotion:  
Total e-Points earned = Product Value (RM) \* 2
- Example:  
Product Value (Actual Selling Price) = RM5,000  
After 2X e-Points = 5,000 e-Points \* 2  
Total e-Points earned = 10,000 e-Points  
Equivalent e-Voucher value = RM100
18. Calculation for 4X e-Points for selected Panasonic Products under the Promotion:  
Total e-Points earned = Product Value (RM) \* 4
- Example:  
Product Value (Actual Selling Price) = RM5,000  
After 2X e-Points = 5,000 e-Points \* 4  
Total e-Points earned = 20,000 e-Points  
Equivalent e-Voucher value = RM200
19. E-Voucher can be redeemed at the Panasonic Online Store.
20. All collected information will be traced and recorded through PANASONIC's internal system.
