### The Body Shop 25% Deal Terms and Conditions

**Before using The Body Shop 25% Deal by redeeming the Deal Code, please spend a few minutes to read the following Terms and Conditions. By using this Deal, we will assume that you have read these Terms and Conditions and that you have agreed to them. They are binding on CLUB Panasonic, Body Shop and Deal users.**

1. The Deal is issued by PANASONIC MALAYSIA SDN. BHD. (26975-W), hereinafter referred to as "PANASONIC", in collaboration with The Body Shop Malaysia, owned and operated under licence by Rampai-Niaga Sdn Bhd (117711-H), hereinafter referred to as "The Body Shop".
